

Cedar Ridge Outfitters Hunting Contract

- 1. This contract is between Cedar Ridge Outfitters LLC, 2229 Liberty Ave. Morrowville, Ks and the below said client.**
- 2. The following will be provided by Cedar Ridge Outfitters staff but not limited too:**
 - Meals, dining, sleeping facilities and bedding, shower and toilet facilities.**
 - Game handling in the field to camp or processor.**
 - Game Cleaning Room. There are several pieces of equipment provided to you to package your meat home.**
 - Transportation will be provided from either Kansas City Airport or Lincoln Airport for \$100 with prior arrangements made from client and Cedar Ridge Staff. If a different Airport is used please call to make arrangements.**
 - Leased Ground to hunt.**
- 3. Hunters Shall Furnish but not limited too:**
 - All personal items, (Toothbrush, toothpaste, clothing, gear, etc.)**
 - Weapon for which the season and ammunition.**
 - Valid license's for the hunt.**
 - Hunter orange hats and vests if applicable for the hunt.**
- 4. Hunters are expected too:**
 - Conduct themselves in civil orderly manner at all times.**
 - Practice safe and legal hunting practice.**
 - Follow all Kansas Department of Wildlife regulations and laws at all times.**
 - Pay any extra processing costs: This includes but not limited too: Staff processing of meat, Staff caping, Staff cleanup of game cleaning room, damage to property leased or owned.**
 - The undersigned shall not directly or indirectly compete for property Leased by Cedar Ridge Outfitters for (5) years from the execution of this contract and will accept all liability for breach of contract by the state of Kansas.**
- 5. The undersigned acknowledges the following:**

- **Hunting involves a certain inherent risks of loss, injury, or illness. Each hunter will assume these risks at their own will by hunting at or with Cedar Ridge Outfitters. Each hunter agrees to indemnify and hold harmless Cedar Ridge Outfitters, its employees, agents, contracted personnel, Lease Holders, from any and all liability costs, claims, or demands, including any and all legal action, including attorneys fees.**
- **Payments will be made as follows:**
- **First half of total hunt price is due upon booking or by Jan 1. of the year the hunt is to take place. This is called the deposit. The deposit is non-refundable for any hunt excluding deer hunts. The deposit of a deer hunt with proof provided to Cedar Ridge Staff that they unsuccessfully draw a tag will be returned. ***PROOF MUST BE PROVEN that your application was filled out correctly and on time.*** Failure to provide this information will result in no refund!!!**
- **Second half of payments will be due 30 days prior to arrival at camp.**
- **Failure to make balance due payment on time will result in legal action against the client. The Client will assume all costs associated with recovery of money.**
- **There will be no refund or proration due to inclement weather or for any other reason beyond control or Act of God provided by Cedar Ridge Outfitters.**
- **Cedar Ridge Outfitters will be measuring every deer killed. If the deer does not meet the minimum of 130" a \$1,000 fine will be enforced. The fine is to be paid within 14 days the animal was harvested to Cedar Ridge Outfitters.**
- **If a client is unwilling to abide by the terms, conditions, or desires of this contract or verbally stated, at the sole discretion of Cedar Ridge Staff holds the right to refuse service and end the clients hunt and ask them to leave camp with no refund.**
- **There is no guarantees for harvests.**
- **Cedar Ridge Outfitters assumes no liability for any extra hunting done on WIHA areas outside of leased property.**
- **The undersigned allows Cedar Ridge staff to take pictures, video, media for use on the internet, tv, publications, or place we see fit.**
- **Any lawsuit, judicial proceeding, or any other action concerning to this contract of provisions hero shall be conducted only in the state of Kansas. The client damages**

• are limited to the price paid by the client directly to Cedar Ridge Outfitters as the consideration for this agreement. No Claim shall be made for proximate damages of a different amount nor may any recovery be had for incidental or consequential damages. The undersigned shall not engage directly or indirectly in any slanderous, libel, or defamatory activity against Cedar Ridge Outfitters verbally or in writing and agrees to accept any and all liability for such activity. If any party hereto pursues legal enforcement of this contract the non-prevailing party shall pay the costs of attorney fees of prevailing party.
